## VALLEY COUNTY PROBATION DEPARTMENT AGREEMENT OF SUPERVISION

<b>1. LAW AND COOPERATION</b> : I shall respect and obey all laws and comply with any lawful request of my supervising officer or an agent of the Valley County probation Department
<b>2. RESIDENCE:</b> I shall not change residence without first obtaining written permission from my supervising officer
<b>3. REPORTS:</b> I will submit a truthful, written report to my supervising officer as directed, and shall report in person on date and times specified. I understand that staying in contact with my supervising officer is my responsibility and failing to do so coul result in a probation violation or sanction
<b>4. TRAVEL:</b> I will not leave the state of Idaho without first obtaining permission from my supervising officer
<b>5. EMPLOYMENT:</b> I shall seek and maintain employment, or a program approved by my supervising officer, and shall no change employment or program without first obtaining written permission from my supervising officer
<b>6. SEARCH:</b> I hereby waive my rights to be free from search under the Fourth Amendment of the United States Constitution and Article 1, Section 17 of the Idaho Constitution and agree and consent to a search of my person, automobile, real property, an any other property at any time and at any place by any probation officer or any law enforcement officer or peace officer
<b>7. WEAPONS/CONTRABAND:</b> I shall not purchase, carry, own, or have in my possession or control any firearm ammunition, explosives, or other weapons. Firearms, weapons, and contraband seized will be forfeited to the Valley Count Probation Department for disposal
<b>8. CONTROLLED SUBSTANCES:</b> I shall not use or possess any controlled substance unless lawfully prescribed by licensed physician. I agree to submit to tests for controlled substances or alcohol, at my own expense, as requested by my supervising officer or any agent of the Valley County Probation Department
<b>9. FINES AND RESTITUTION:</b> I shall pay fines and/or restitution and other fees as ordered in the sum of \$ Payments will be made as per my deferred agreement with the Court. A receipt for all payments will be submitted to m supervising officer each month until paid in full
<b>10. ASSOCIATIONS:</b> I shall not associate with persons or in places deemed inappropriate by the Court or my Probatio Officer upon receiving written notice
11. ALCOHOLIC BEVERAGES: I will not purchase, use or have in my possession any alcoholic beverages or enter an establishment engaged in the sale of alcohol for consumption on the premise
<b>12. LAW CONTACTS:</b> I will report any contact I have with Law Enforcement to my Probation Officer within 24 hours of said incident. This includes all misdemeanor and felony crimes whether I am present, questioned, involved, or arrested for said crime or incident
<b>SPECIAL INSTRUCTIONS:</b> (A) I will successfully complete, at my own expense, alcohol/drug treatment a recommended by my supervising officer. I will agree to be placed with an alcohol/drug electronic monitoring device and pay the expenses associated with it as recommended by my supervising officer  (B)
I have read, or have had read to me, the above agreement. I understand and accept the conditions of supervision under which I hav been released. I agree to abide by and conform to them and understand that my failure to do so may result in the revocation of m probation.
